

EMPLOYMENT CONTRACT

This contract made and entered into this 12th day of June, 2017, by and between the Board of County Commissioners of Sheridan County, Kansas, hereinafter referred to as Board and David Stithem.

In consideration of the mutual covenants and agreements of the parties and the monetary consideration hereafter mentioned, the parties hereto agree to the following:

1. The Board hereby employs David Stithem as the County Appraiser for Sheridan County.
2. As and for consideration of the employment listed above, the Board shall pay David Stithem the sum of \$5,194.17 plus longevity per month. Such contract to be effective July 1, 2017 and continue for a term of four (4) years in accordance with Kansas Statutes.
3. The County Appraiser is the department head and is responsible for all the administrative and technical work involved in the operation of the County Appraiser's office. This position is responsible for the performance of duties as defined by Kansas Statutes.
4. The Board hereby employs David Stithem as County Computer Technician for Sheridan County.
5. As and for consideration of the employment listed above, the Board shall pay David Stithem the sum of \$1733.33 plus longevity per month. Such contract to be effective July 1, 2017 and continue for a term of four (4) years.
6. The County Computer Technician is the department head and is responsible for supervising and managing the County's PCs, PC software and servers, and shall serve as the contact person when repairs and maintenance work is to be done on these computers.
7. The Board hereby agrees that because of the nature of the above-mentioned positions, David Stithem shall have a flexible work schedule.
8. The Board considers these positions full-time, and as such, David Stithem is entitled to all benefits given by the Board to their full-time employees. The Board will provide a yearly review to determine if David Stithem is entitled to a cost of living/salary increase. The Board will provide David Stithem with paid family health insurance.
9. This Employment Contract shall be for a term beginning July 1, 2017, and terminating June 30, 2021, SUBJECT HOWEVER, to the provision that said employment term will be automatically extended for an additional four (4) year period beginning on July 1, 2021, unless either party shall have given the other written notice to vacate this provision by April 1, 2021.

**RESOLUTION NO 17-02A**

NOW, THEREFORE, BE IT RESOLVED BY ORDER OF THE BOARD OF COUNTY COMMISSIONERS, SHERIDAN COUNTY, KANSAS, that David Stithem be appointed as of July 1, 2017, as County Appraiser of Sheridan County, Kansas, for the term of office ending June 30, 2021.
