Christen Secrest, Assistant County Attorney, states and alleges that **Amy Sue Sloan** committed the following crime(s):

**COUNT ONE**

**FAILURE TO REPORT CHILD ABUSE OR NEGLECT AS MANDATORY REPORTER**

That between the 11<sup>th</sup> day of February, 2025 and the 7<sup>th</sup> day of April, 2025 in Leavenworth County, Kansas, **Amy Sue Sloan** was a mandatory reporter as defined in K.S.A. 38-2223(a)(1)(C), and had reason to suspect that a child, (E.R.C. DOB- XX-XX-2017), had been harmed as a result of physical, mental, or emotional abuse or neglect or sexual abuse, but did willfully and knowingly fail to make a report as designated in K.S.A. 38-2223(b)(1). In violation of 38-2223(a)(1)(C),(b)(1), & (e)(1), Failure to Report Child Abuse or Neglect as a Mandatory Reporter, a Class B Misdemeanor.

## **COUNT TWO**

### **FAILURE TO REPORT CHILD ABUSE OR NEGLECT AS MANDATORY REPORTER**

That between the 11<sup>th</sup> day of February, 2025 and the 7<sup>th</sup> day of April, 2025 in Leavenworth County, Kansas, **Amy Sue Sloan** was a mandatory reporter as defined in K.S.A. 38-2223(a)(1)(C), and had reason to suspect that a child, (M.E.B. DOB- XX-XX-2016), had been harmed as a result of physical, mental, or emotional abuse or neglect or sexual abuse, but did willfully and knowingly fail to make a report as designated in K.S.A. 38-2223(b)(1). In violation of 38-2223(a)(1)(C),(b)(1), & (e)(1), Failure to Report Child Abuse or Neglect as a Mandatory Reporter, a Class B Misdemeanor.

## **COUNT THREE**

### **FAILURE TO REPORT CHILD ABUSE OR NEGLECT AS MANDATORY REPORTER**

That between the 1<sup>st</sup> day of October 2023 and the 7<sup>th</sup> day of April, 2025 in Leavenworth County, Kansas, **Amy Sue Sloan** was a mandatory reporter as defined in K.S.A. 38-2223(a)(1)(C), and had reason to suspect that a child, (E.K.E.G. DOB- XX-XX-2014), had been harmed as a result of physical, mental, or emotional abuse or neglect or sexual abuse, but did willfully and knowingly fail to make a report as designated in K.S.A. 38-2223(b)(1). In violation of 38-2223(a)(1)(C),(b)(1), & (e)(1), Failure to Report Child Abuse or Neglect as a Mandatory Reporter, a Class B Misdemeanor.
